Employee Gaming Prohibition Request and Agreement

I, _____ acknowledge that I am a problem gambler and voluntarily seek to be permanently prohibited from gambling at the Muckleshoot Casinos and Bingo Hall. I hereby request and authorize the Muckleshoot Gaming Commission to permanently prohibit me from participating in all gambling activities at any Casino or Bingo Hall operated by the Muckleshoot Indian Tribe, and to prohibit me from being on the premises of such facility, except as expressly provided herein. I have reviewed and understand the following terms of this gambling prohibition and agree to all of the terms. I further understand that any violation of the terms and conditions of this Agreement may result in my being permanently barred from entering the premises of the Muckleshoot Casinos and Bingo Hall and may result in termination of my employment.

Terms and Conditions

- The undersigned employee shall not participate in any gambling activity at the Muckleshoot Casinos, Muckleshoot Bingo Hall or any other gaming facility operated by the Muckleshoot Indian Tribe.
- The undersigned employee shall not enter or remain on the premises of the Muckleshoot Casinos or Bingo Hall or any other gaming facility operated by the Muckleshoot Indian Tribe, except to perform job duties and to pick up or drop off immediate family members employed in those facilities. The undersigned employee will leave the premises of the Muckleshoot Casinos and Bingo Hall promptly upon conclusion of his or her shift, and understands that he or she is barred from entering these facilities for any purpose, including nongaming purposes outside of his or her work hours, except as provided above for the purpose of picking up or dropping off a member of his or her immediate family employed in such facility.
- The undersigned employee shall be promptly escorted from the gaming facility in the event that he or she violates the provisions of this Agreement and the violation shall be reported to the Muckleshoot Gaming Commission and appropriate Human Resource Department.
- The undersigned employee agrees that any gambling winnings or jackpot earned as the result of gambling activities in violation of this Agreement shall not be awarded to the undersigned, but shall be forfeited to the Gaming Facility and donated by the Gaming Facility to a non-profit charitable organization.
- The undersigned employee agrees that in the event either voluntary or involuntary termination of his or her employment that this Employee Gaming Prohibition Request and Agreement shall become a permanent self-bar from the Muckleshoot Casinos and Bingo Hall for problem gambling. In the event the undersigned should later apply for reemployment, the undersigned will be required to seek modification of the self-bar by the Muckleshoot Gaming Commission to allow access to the gaming facilities before being rehired. The undersigned understands that such modification is at the sole discretion of the Muckleshoot Gaming Commission and may be denied.
- The undersigned employee understands and agrees that this Agreement and prohibition on gambling activities shall be permanent and irrevocable when signed by the employee and approved by the Muckleshoot Gaming Commission.
- The Muckleshoot Gaming Commission will notify the gaming facilities of this Gaming Prohibition Request and Agreement. A photocopy of the undersigned employee and a copy of this document shall be forwarded to Surveillance and to the MGC Enforcement agents.
- The undersigned employee understands and agrees that he or she is solely responsible for any gambling activity in which he or she participates. The undersigned employee further agrees that the Muckleshoot Indian Tribe, its Gaming Commission, Gaming Agency, Casinos, Bingo Hall, gaming facilities, officers, agents and employees shall not be liable in any manner for any losses or damages whatsoever that result from the employee's violation of this Agreement, the failure to enforce this Agreement, the withholding or restoration of gaming privileges, or any other reason arising out of this Agreement.
- The undersigned employee on his or her own behalf, and on behalf of his or her heirs, executors, administrators, successors, and assigns, hereby releases, and forever discharges the Muckleshoot Indian Tribe, its Gaming Commission, Gaming Agency, Casinos, Bingo Hall, gaming facilities, and their officers, agents, and employees and those with whom they share information regarding this Employee Gaming Prohibition Request and Agreement from any and all claims in law or equity that the undersigned may now have, or may have in the future, against any and all of the released parties arising out of, or by reason of, the performance or non-performance of this Agreement, or any other matter relating thereto. The undersigned further agrees to indemnify and hold harmless the released parties to the fullest extent permitted by law for any and all liabilities, judgments, damages, and expenses of any kind, including reasonable attorneys' fees, resulting from or in connection with the performance or non-performance of this Agreement.
