

Muckleshoot Gaming Commission

Licensee Responsibility Agreement

I, _____, understand that if granted a license by the Muckleshoot Gaming Commission to work in a gaming facility under the jurisdiction of the Muckleshoot Gaming Commission, that I must promptly notify the Muckleshoot Gaming Commission Licensing Department if any of the following occur:

1. *Any change of address or phone number*
2. *Any change in name, this includes name changes from Marriage, Divorce, and other legal name changes recognized by a court of law*
3. *Any arrest, pending criminal charges, or convictions that occur during my employment with a gaming facility under the jurisdiction of the Muckleshoot Gaming Commission. I also agree and understand that I must provide any requested documents related to an arrest, pending charges or convictions to the Muckleshoot Gaming Commission upon request.*

I understand that failure to properly notify the Muckleshoot Gaming Commission of any of the preceding events **within 48 hours** of the occurrence could cause action against my license up to and including revocation depending upon the severity. _____ (*Initial you understand the 48 hr. notification requirement*)

I further acknowledge and agree that while my license or upgrade is pending with the Muckleshoot Gaming Commission that I may not work in the capacity for which I am applying for a license or upgrade.

I also understand that it is my responsibility to know the proper procedures and any laws, Tribal Codes, or Rules that are relevant to my position and to stay apprised of any changes in those policies and or procedures.

If the employer or I terminate my employment I agree and understand that I must return my identification badge, as it is the property of the Muckleshoot Gaming Commission.

I understand that any violation of any of the provisions of the Muckleshoot Gaming Ordinance or any of the Commission's rules or regulations by a licensee, his/her agent, or employee shall be deemed contrary to the health, security, and general welfare of the Tribe, the players, and the community and shall be deemed grounds for refusing to grant or renew a license, or suspension or revocation of a license. Acceptance of a gaming license or renewal thereof, or condition imposed thereon, by a licensee, constitutes an agreement on the part of the licensee to be bound by all the regulations and conditions of the Director or the Commission and by the provisions of the Muckleshoot Gaming Ordinance and regulations. I will cooperate fully with the Director and the Commission. It is the responsibility of the licensee to keep himself/herself informed of the contents if all such regulations, amendments, provisions, and conditions, and ignorance thereof will not excuse violations.

I also understand that if I furnished untrue or misleading information on my application, or demonstrated willful disregard for the compliance with ordinances, statutes, administrative rules, or court orders at the Tribal, Local, State, or Federal level, or knowingly fail to report to the Commission immediately a known violation of applicable laws or regulations involving gaming activities or employees, that this is grounds for denial, suspension or revocation of my gaming license.
